Is there currently any land zoned as agricultural within the Village of Richmound?

Answer: No. At this time, there are no lands formally designated as *Agricultural* within the Village of Richmound. While a small parcel of land is presently being used for agricultural activities, its official land-use classification is **Future Urban Development** rather than Agricultural.

This designation permits the existing agricultural operations to continue without interruption; however, it also signals that the land is intended for potential urban growth or redevelopment in the future. Any new development or change in use would require an application and approval from Council, ensuring that future decisions align with the community's long-term planning objectives.

REQUEST FOR FREE GAMES NIGHT:

331/25 WELTE: THAT we acknowledge the Fundraising Committee will charge \$5 per person for games night, and will not be charged for rental. The \$5 fee per person will be paid to the Village of Richmound and the end of every month. Costs will be reviewed every 3 months. Carried.

LOCK BOX:

332/25 BULLOCK: THAT we authorize the purchase of a lock box for Hall key storage to be stored outside of the Community Hall. Code on lock box to be changed monthly. Carried.

RUG RUNNER:

334/25 MILLER: THAT Hall purchases up to \$200 may be approved by Council via WhatsApp, as to provide for efficient turnaround of small items purchased. Carried.

- Statement that if roof gets overloaded with snow, that it is removed to not cause a collapse
